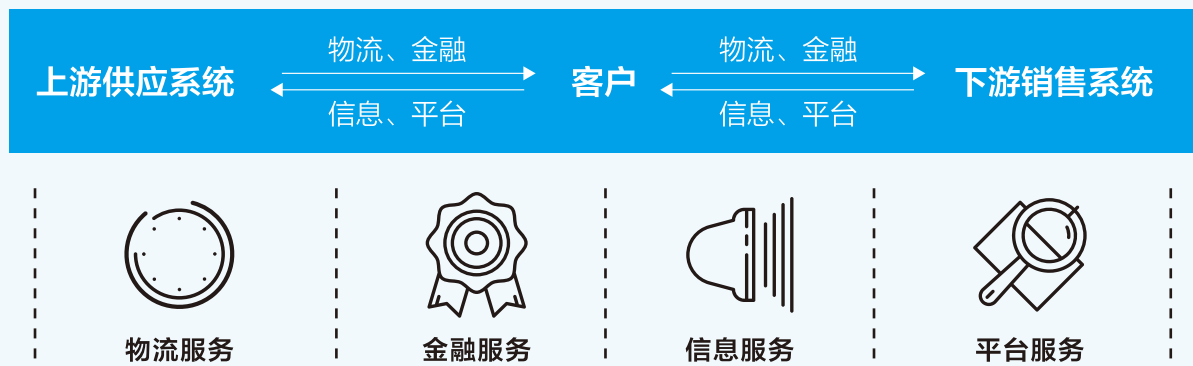

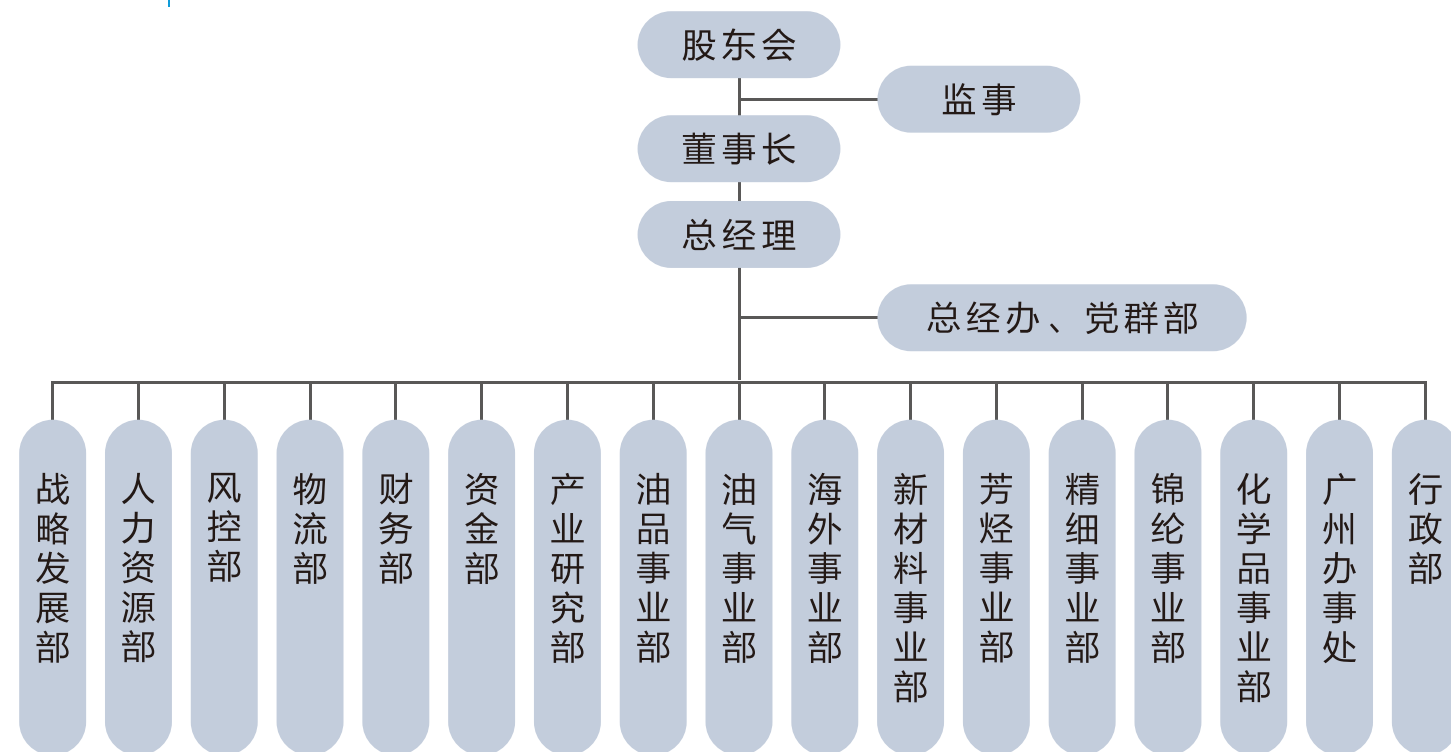

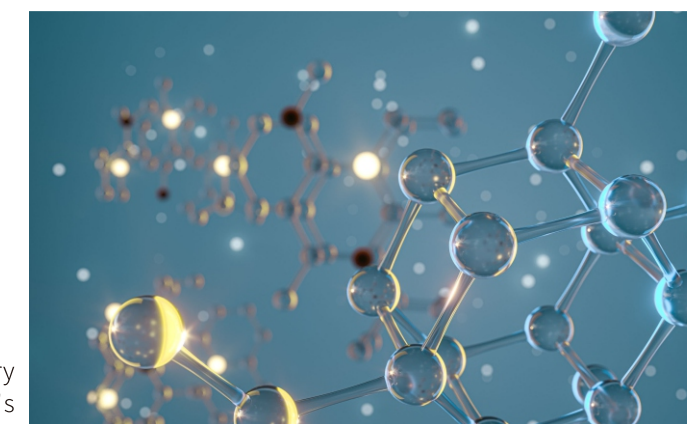

化学品板块 CHEMICAL SECTOR

主营化学品业务，其中主要包括液体化工和橡胶塑料业务。提供液体化工产品整套供应链集成服务，为优质外企提供国内分销服务。主营产品包括：增塑剂（DOP、DBP、DOTP等）各种苯类、醇类液体产品，以及聚丙烯、聚乙烯、聚氯乙烯、聚苯乙烯、热塑性丁苯橡胶、丁基橡胶等。目前已与中石化、中石油、沙比克、大韩油化、三星物产等优质企业进行长期战略合作。

Mainly engaged in the chemical business, which mainly includes liquid chemicals and rubber and plastic business. We provide a complete set of supply chain integration services for liquid chemical products and domestic distribution services for high-quality foreign enterprises.

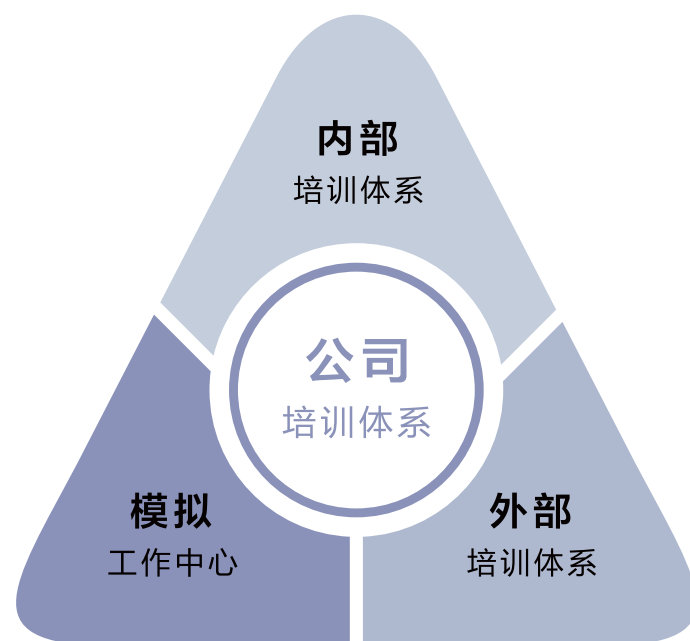
